**Bryan R. Early** is an assistant professor in the Political Science and Public Administration & Policy Departments at the University at Albany, State University of New York. He previously served as a fellow with the Dubai Initiative at Harvard University's Belfer Center for Science and International Affairs and as a research associate with the University of Georgia's Center for International Trade and Security.
